1. Welcome and Opening

- **3. Quorum** Ellen Ostbo, Secretary, confirmed that there was a quorum (81 of 147 active members) in attendance to discuss business. (List of Attendees, attached)

- **B.** Pastor Joshua Stager confirmed with all present that there were no objections to the Agenda:

 - **b.** Coffee Bar allocation increased to reflect actual expense.
 - **c.** Senior Pastor Salary is omitted since the position is not anticipated to be filled prior to June 30. 2024.
- **B.** Jeff Robison moved that the first six-month 2024 Budget totaling \$227,318 be approved, Rick Carpenter seconded, and approved.

Ministry Reports

2024: Stepping into God's Plan with Momentum and Expectancy

Canby Alliance Church Family, it has been exciting to work together with so many in our church. We've entered into this exciting adventure, and there's a growing sense of anticipation and expectancy. We keep asking ourselves, "What does God have in store for CAC next? What does God have in store for our lives as we follow Him together with our church family?" It's all pretty exciting! We, as your leadership, would like to give you a quick overview of everything that's been happening at CAC since January 1, and to celebrate all our ministry participants for the time and effort they give to building up the Body of Christ!

PEAK Process

The PEAK process, though long and labor-intensive, has helped us redefine who we are as a church. It has given us a clearer understanding of our community and its needs, a deeper love and burden for those around us, and more intentionality in engaging with our community and genuinely loving our neighbors. This has been incredibly transformative for us at CAC. The process identified three key themes we must pursue to fulfill God's call on our church:

- Intentional Discipleship: Creating opportunities for growth in Christ
- Loving Community: Offering welcoming hospitality to all, especially those new to us
- Gospel Proclamation: Focusing locally, sharing the gospel in word, deed, and sign

We celebrate working together toward a new vision for our future as a church family. Deep connections were formed that continue into the Pastor Search committee and have given us one heart and one mind as we seek God's plan and purpose for our next pastor!

Pastor Search Committee

God surprised us with over 20 applicants, and we see His provision in every step of this process.

Good Neighbor Alliance - Emergency Preparedness Event

Again, focusing on the PEAK themes of Loving Community and Gospel Proclamation, a group of us who live close to the church are inviting 250 households our immediate neighbors (those within a couple of blocks of the church) to an event on September 8. We have a fantastic group

of leaders taking on the responsibility of planning and implementing this event, and as leadership, we're coming alongside them to release them to do ministry. It's all part of our desire to be a more integral part of the neighborhood and to love our neighbors in practical ways.

Willamette Valley Big Band Concert

In pursuit of the PEAK themes of Loving Community and Gospel Proclamation, we opened our building to the community for a Big Band concert on May 2, with CAC members providing hospitality to the guests. We're grateful to everyone who stepped up to love our neighbors, and we look forward to the next opportunity to reach out to our community!

Small Group Ministry

Connected to the PEAK theme of Intentional Discipleship, we opened up small groups in January and February. The response was phenomenal! With 11 groups and over 100 participants, small groups have provided the vast majority of our church members with the opportunity to love God and love one another. We're excited for a new season of small groups, filled with intergenerational innovation and growth in our love and understanding of Jesus Christ!

Youth Ministry

We've had a busy and impactful few months in youth ministry! Twenty-three times, our middle-and high-school students have come together over meals provided by our amazing church family. This group, averaging 57 students, is mostly comprised of people outside our church (91%), invited by our team. Back in February, 18 of our high school students met for three days at our annual beach retreat, DARUDE, to grow closer to God and each other. We have an exciting road ahead as we gear up for the rest of the year. With 11 dedicated youth leaders on board, we're ready to keep building on the momentum we've gained, staying focused on reaching out, making disciples, and creating a space where all students feel welcomed and loved. We celebrate Nick's intentional planning to engage the youth in the truth of the Bible!

Children's Ministry

We believe in learning together and responding to God, recognizing everyone's need for Him. Our Sunday programs, Sparks (ages 5-9) and Embers (ages 1-4), embody that ideal. We've seen intergenerational participation in worship through two baby dedications this year and Sparks'

participation in the big worship service (including a Sparks kid praying from the front). In March, we began a midweek ministry for 4th and 5th grade students called Blaze, which is increasing its coordination with the middle school and high school midweek gathering. Our summer theater camp, CREATE, served 51 campers and engaged 34 volunteers (5 of them youth) through our continuing partnership with The Canby Center. We celebrate Rachel's heart for giving children the space to express themselves, and we look forward to more intergenerational participation in the coming year.

Worship Ministry

Over the past eight months, our worship and tech teams have grown significantly. This growth has been a true blessing! Josh Payne has been attending a worship and tech program to sharpen his skills and better serve our church. We've introduced new software and are working on stage design enhancements to keep our worship experience evolving and engaging. We celebrate Lori Yamase's leadership in preparing communion and celebrate Josh's Spirit filled presence and petition on behalf of our congregation!

Men's Ministry

This past year, about a dozen of us have met for breakfast and fellowship each month. We pray, do a short devotional, chat, and pray for each other. Some of these same men are working with men of all ages and are planning a men's retreat for Spring. Our Wednesday morning men's Bible study is a place to get prayer support, be encouraged in tough times, and stimulate our personal growth in Scripture. This has become a structured time to focus on topics from Biblical times and how they apply to us today, helping to carry us from Sunday to Sunday.

Women's Ministry

A big thank you to Sarah Minson for facilitating a wonderful CAC Spring Tea party on April 24, and to the many ladies who helped with setup, baking, serving, and making this event happen. We're also grateful to the hostesses of the Women's Summer Tea Fellowship: Elaine Gingerich, Bette Vaudt, Nancy Pickett, Joanna Crumley, and Ginny Hartle. Thanks to Victoria Hannaman and Jackie Thornton for leading Solo Sisters and creating events and spaces for ladies to encourage each other, enjoy fellowship, and have fun together. We also appreciate Lynne Brown and Sally Jo Brown for hosting an online Bible study so ladies can study the Word and grow together. Thank you, ladies, for saying yes to the Holy Spirit's promptings.

Women's Prayer Team

Lois Thiessen led a mini-retreat for our team in February and we are asking God to create a culture of prayer in the church. We provide prayer every Sunday in the service and we meet once a month to pray for the requests that have been sent to us! We look forward to God's heart to deepen a culture of prayer at CAC

Deaconesses

The deaconesses have invited other ladies of Canby Alliance and, together, provided meals for those who are experiencing serious physical ailments and challenges. Cards and flowers have been faithfully shared with others experiencing loss or serious procedures. Encouragement for one another abounds in these servant activities

Missions Ministry

In our February trip to Guinea, we re-established our partnership with the Conakry Youth Team, and connected our new missions team member Stephanie Winningham with the work being done in Conakry. Josiah Keen also visited the work being done in Guinea in July. We walk forward with hope and expectancy for what God is doing through our international partnerships.

Preaching Teams

Since January 1, we've had the opportunity to hear from twelve of our CAC members and seven different speakers from our greater C&MA family. It's been great hearing from so many brothers and sisters from the pulpit. Perhaps the greatest joy has been hearing personal stories of how people are drawing closer to God and really listening to what He is saying.

New Members

Between February and September, we've added 18 new members—more than we've ever had in a single year! It's exciting to see people responding to the call to become members because they feel committed to CAC and the work we're doing in our community. The elders have been encouraged by hearing about the work of Christ in the lives of our new members!

Elder Newsletters

We believe this tool has been helpful in bringing the church into the journey of the PEAK process and embracing what we've discovered. It's been instrumental in gaining "buy-in" from the church. We believe communication has kept everyone informed. We celebrate Mel's awareness of the presence of God even in the smallest of moments!

Coffee Bar

While continuing our commitment to open the coffee bar during the school year, this summer we also kept it open, serving drinks to the congregation and visitors, encouraging fellowship before and after each Sunday service. Coffee is part of being a loving community!

Susu Prayer Team

We have a team of people who have signed up to get monthly updates about the needs of those serving the Susu people, both in Guinea (LaZone) and Sierra Leone (Susu Gospel Ministry). There is a scheduled zoom prayer meeting on the second Tuesday of each month. If CAC people would like to be added to this list, contact Nancy Pickett.

Financial Update

God works in the details, too! Effective July 1, Canby Alliance made the move to a different merchant service that processes your online payments. The advantage is a streamlined process behind the scenes, with everything now handled in one spot. This change makes things much easier for our Office Manager, Treasurer, and Financial Secretary.

Administration

The Administrative Board welcomed three brand-new members this year, and one of them offered this perspective: "Thank you, church family, for giving me the opportunity to serve on the CAC Administrative Board. What an awesome experience it is to work with such a talented and dedicated team. We routinely celebrate God's blessings and goodness poured out on our church family!" We celebrate Melinda's care for those seeking support and love from the front office. We also celebrate Joshua Stager's support and development of each staff member's giftings.

Kapok Care

Kapok Care is the name of the new non-profit organization we started to take on the project of building a hospital in Sierra Leone in partnership with the Susu Gospel Mission. This is a massive undertaking, and we know this dream will only be realized if it is God's will. So far, it's been amazing how God keeps showing up as we work on this project. We're currently in the process of adding basic surgical services to the existing clinic. This is moving along well and should be operational very soon. The larger dream of a hospital in Lungi is making progress; we've purchased land and will begin building a wall and adding a well later this year. We appreciate your prayers for the project and look forward to having a cost estimate so we can start more formal fundraising soon! There is a weekly prayer team for people interested in praying for this project every Sunday morning in the prayer room at 8:30.

Facilities

We continue to host outside religious organizations (Classical Conversations, Canby Spanish Seventh Day Adventist Church) and community groups (Canby Mom's Club, TOPS, pick-up basketball, Willamette Valley Big Band). This is part of being a Loving Community. We've also made changes for facility maintenance (gym wall repair, plumbing leak repair), internet security (DirectLink internet access point upgrade), and cost savings (renegotiating our contract with Roth).
